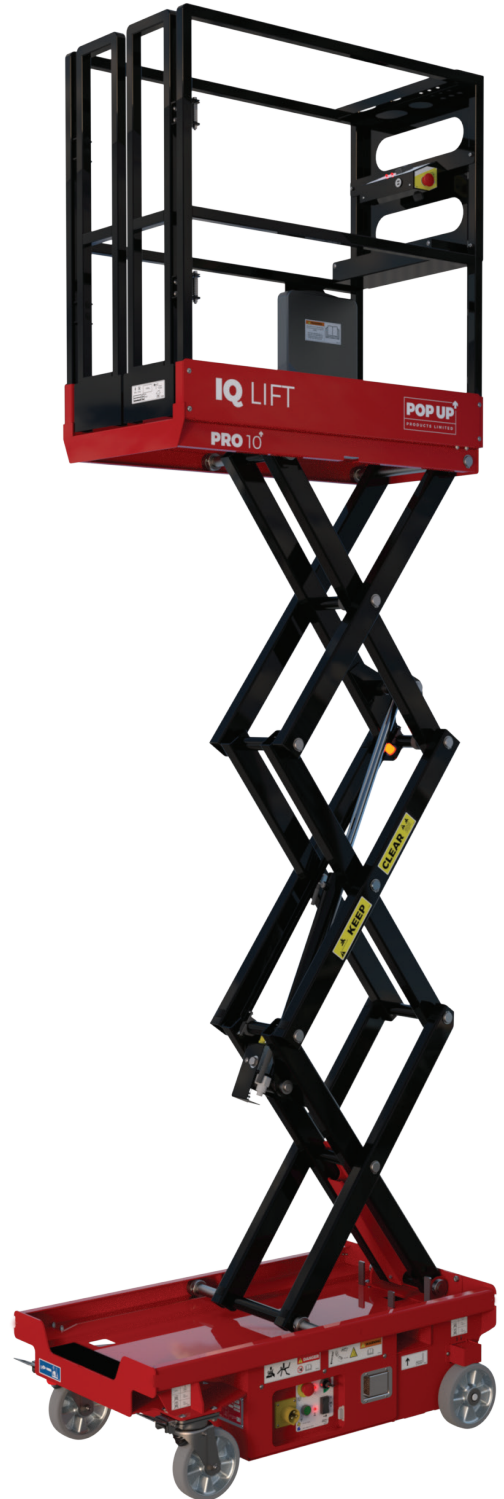

This handbook is considered part of the machine and must be stored on the machine at all times.

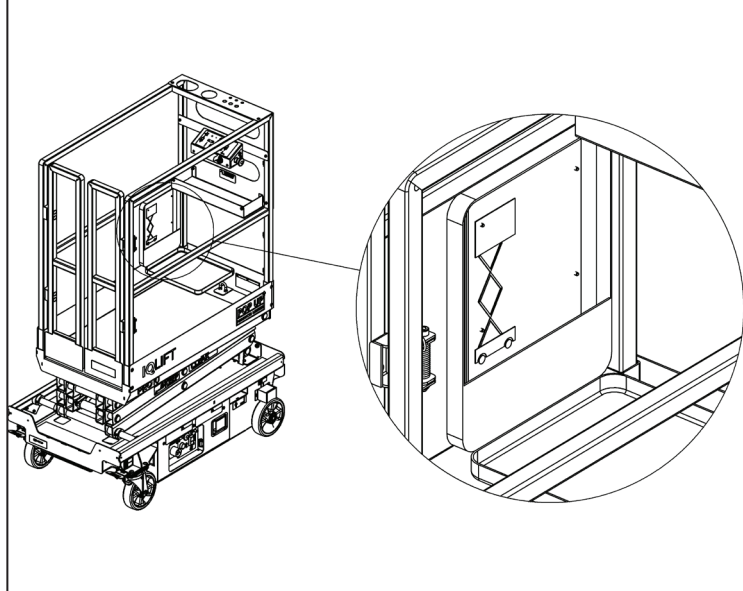


FIGURE 1: Handbook Storage Location

FALL PROTECTION

Fall Protection Notice:

The guardrail system around the perimeter of the platform is the fall protection system for Mobile Elevating Work Platforms per the MEWP standard. It is prohibited to use this MEWP with any portion--or all--of the guardrails removed. Anchorage points are provided for work positioning restraints only. Lanyard lengths are to be determined by the operator/owner to restrict the operator to the confines within the guardrail system.

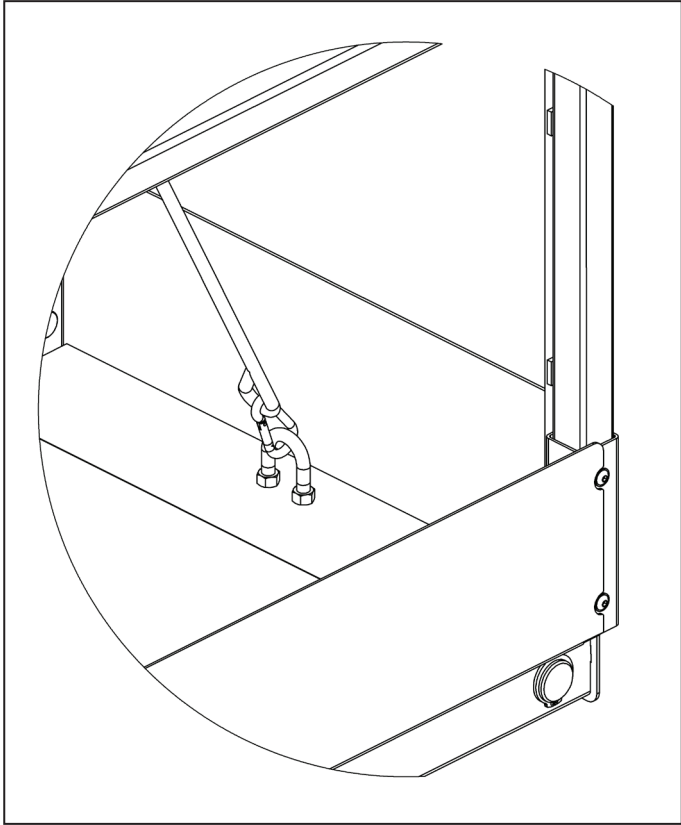


FIGURE 2: Anchorage

SECTION 1 | PRODUCT DESCRIPTION

1.1 | PRODUCT INFORMATION

Pop Up Products' IQ Lift is a Mobile Elevating Work Platform designed to be safe and reliable. The purpose of the machine is to elevate personnel, along with their necessary tools and materials. The machine is intended for indoor use (no wind load). Manufacturer approval is required for any use other than the intended use.

SECTION 2 | SAFETY

2.1 | SAFETY SYMBOLS

Warnings and instructions that have a direct impact on safety are identified with the following signals:

2.2 | GENERAL RULES AND PRECAUTIONS

An operator of any type of work platform is subject to certain hazards that cannot be protected by mechanical means. It is therefore essential that operators be competent, careful, physically and mentally fit, and thoroughly trained in safe operation of this machine. It is the responsibility of the owner to instruct operators with the safety requirements made not only in this handbook, but by the various safety bodies in your area, as well as additional requirements set forth by EN: 280. If you come across a situation that you think might be unsafe, stop the platform and request further information from qualified sources before proceeding.

Noise and vibration do not create significant hazards on this machine.



DO NOT OPERATE MACHINE NEAR POWER LINES. THE PLATFORM AND ENCLOSURES ARE NOT INSULATED.



NEVER REACH BETWEEN SCISSORS LINKS OR PROP UP PLATFORM.

Maintenance Lock

The maintenance lock must be placed into position whenever the machine is being serviced in a partially raised position. Serious injury and/or death could result if maintenance lock is not used properly.

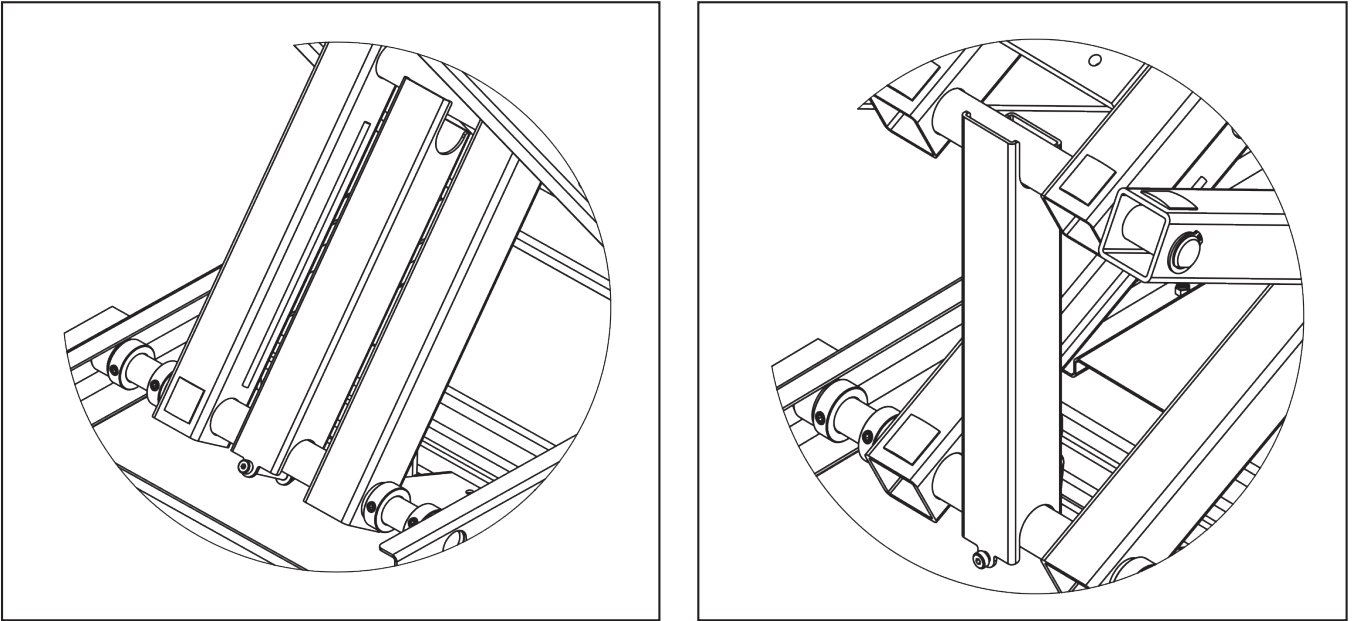


FIGURE 3: Maintenance Lock

SECTION 2 | SAFETY

Only qualified operators may operate this unit.

ALWAYS	read and understand the Operation and Safety Handbook before operating.
ALWAYS	understand all decals and warning labels on unit.
ALWAYS	prevent unauthorised use; when unit is not in use, remove key.
ALWAYS	wear necessary approved personal protective equipment (PPE), i.e. head gear.
ALWAYS	report any misuse of equipment to proper personnel.
NEVER	work on platform if your physical condition is such that you feel dizzy or unsteady.

Use machine only for purposes for which it was intended.

ALWAYS	distribute load evenly over platform floor area.
NEVER	use the lift as a crane (by suspending a load from the platform).
NEVER	exceed the load capabilities of the platform. (See the "Product Description" section of this handbook)
NEVER	use unit as electrical grounds for arc welding.
NEVER	override any hydraulic, mechanical, or electrical safety devices.

Check job site for unsafe working conditions.

ALWAYS	watch out for others. Keep others clear of operating platform.
ALWAYS	avoid contact with fixed (buildings, etc.) or moving (vehicles, cranes, etc.) objects. Check work area for overhead obstructions or possible hazards.
ALWAYS	follow any applicable national traffic regulations.
ALWAYS	be on hard level surface before elevating
ALWAYS	maintain a clearance between any part of the machine, or its load, and any electrical line or apparatus. Follow local power line clearance regulations.
NEVER	allow others to pass under a raised platform or position the platform over someone.
NEVER	use outdoors. Lift is not designed for windy conditions or electrical storms.
NEVER	operate on incline or uneven surface.
NEVER	operate machine near power lines. The platform and enclosures are not insulated.
NEVER	move the unit on a slope steep enough that the unit may become uncontrollable.

Equipment is only as safe as the operator.

ALWAYS	make sure entry gate is secured before operating machine from the platform.
ALWAYS	secure tools and materials.
ALWAYS	maintain a firm footing on the platform floor and work only within the platform area.
NEVER	use ladders or scaffolding on the platform to obtain greater height.
NEVER	enter or exit platform while machine is in motion.
NEVER	mount or dismount a raised platform.
NEVER	move the unit when in the elevated position.
NEVER	move the unit with a person on the platform.
NEVER	belt or tie off to an adjacent structure.

Before operation, ensure that the machine is properly serviced.

ALWAYS	perform inspections and preventative maintenance at the recommended intervals. (See the "Maintenance" section of this handbook)
ALWAYS	use the maintenance lock when performing all types of maintenance procedures.
NEVER	use machine if it is not working properly.
NEVER	smoke while charging the battery.

2.3 | SAFETY CONTROLS & INDICATORS

Emergency Stop

This lift is equipped with two emergency stop switches, one at the platform control and one at the base control, that when activated, will render the unit inoperable until reset. To reset, pull the button out. (See the “Operating Controls & Indicators” section of this handbook for more detail.

Descent Alarm & Lowering Interrupt

An audible alarm sounds when the machine is lowering.

When lowering the platform, the platform will stop when the ends of the scissors are 50mm apart for 3 seconds. The beacon light flashes to indicate the armguard delay. Release. Look around all sides of the scissors to check for persons at risk. Then continue lowering the platform. If elevating platform less than 50mm, the lift will not descend due to the armguard feature. Elevate the platform higher before lowering, or use the manual override in case of emergency.

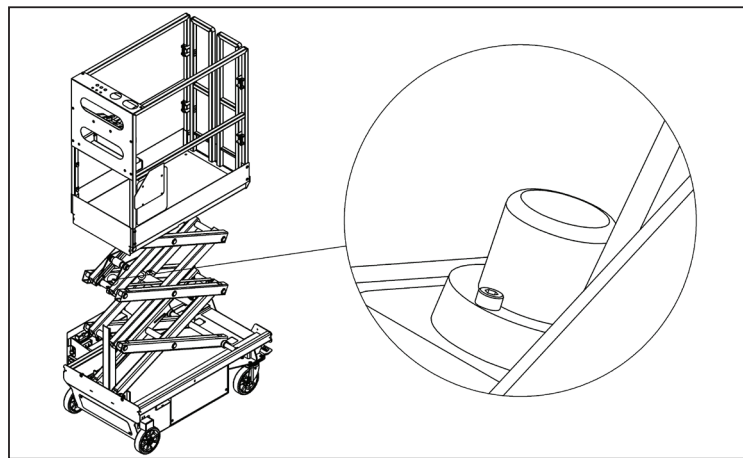


FIGURE 4: Descent Warning Light

Descent Manual Override(Emergency Lowering)

For manually lowering the scissors, a manual valve is provided. To lower the scissors, pull the cable located near the rear of the machine.

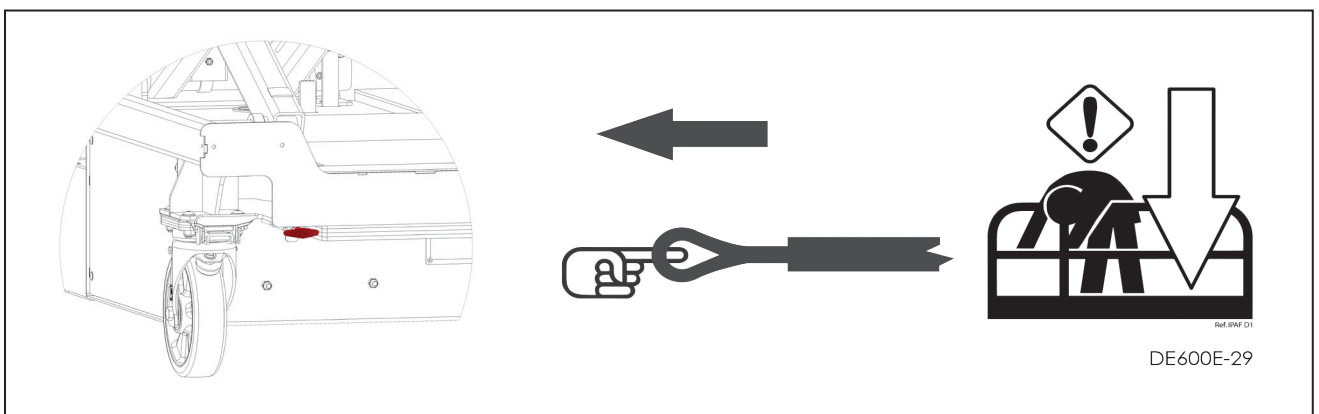


FIGURE 5: Emergency Lowering



IF PLATFORM SHOULD FAIL TO LOWER, DO NOT ATTEMPT TO CLIMB DOWN THE BEAM ASSEMBLY. SERIOUS INJURY MAY RESULT. HAVE AN EXPERIENCED OPERATOR USE THE EMERGENCY LOWERING PROCEDURE TO SAFELY LOWER THE PLATFORM.



Tilt Sensor

If the chassis is tilted more than 1.5°, elevating function is prevented, and an alarm sounds. Lower the platform and move to a hard, level surface before elevating.

Load Sensing

Movement is inhibited when the load exceeds the rated load and elevating is attempted from the stowed position. When the platform is stowed, the overload indicator lights up to indicate that the load control system is functional. Then attempting to elevate, if the load is less than rated load, the light will stop, and elevating may continue. If the rated load is exceeded, the light will continue and the platform will not elevate. Remove the excess load before continuing operation.

Automatic Brakes

When elevated, a brake is automatically applied to the rigid wheels. The manual parking brake on the swivel castors should also be used. (See the "Operation" section of this handbook).

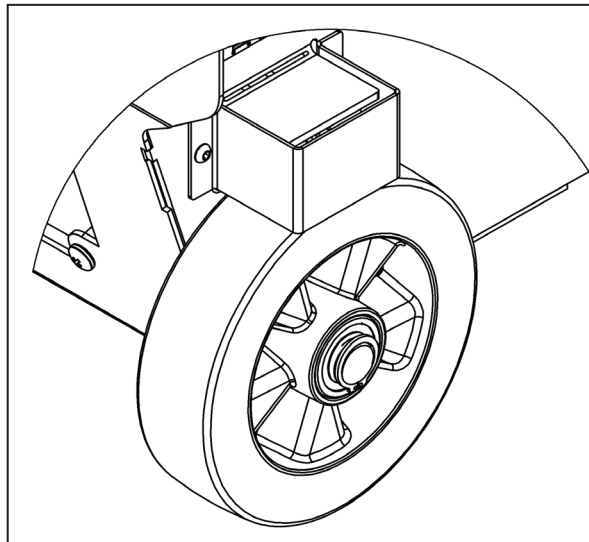


FIGURE 6: Automatic Brake

SECTION 3 | TRANSPORT, HANDLING, & STORAGE

3.1 | PRELIMINARY UNPACKING INSTRUCTIONS AND DEALER INSPECTION

Maintenance locks must be engaged prior to inspecting or servicing the unit when the platform is elevated. Inspect machine for any possible damage during shipment; perform a Pre-Delivery Inspection. See checklist in the Maintenance & Troubleshooting Handbook. Reset emergency stop switches, if necessary.

3.2 | STORAGE

After periods of storage, exposure to extremes of ambient conditions-heat, cold, moisture, dust etc., inspect the machine. Refer to the Pre-Delivery/ Frequent Inspection Checklist in the Maintenance & Troubleshooting Handbook.

3.3 | PREPARATION FOR TRANSPORT

- Lower the work platform to the down position.
- Turn key switch to off position.
- Check entire machine for loose or unsecured items. Remove any loose items from machine.
- For safety and controlled handling, it is not recommended to move the unit on a slope greater than 5°. Apply manual brake lock on rear castors.

3.4 | FORK LIFT POCKETS

Fork lift pockets are provided on the side of the unit for loading and unloading. When moving machine with a forklift, do not let machine slide along floor. Bring forklift to a stop and then gently lower the machine.

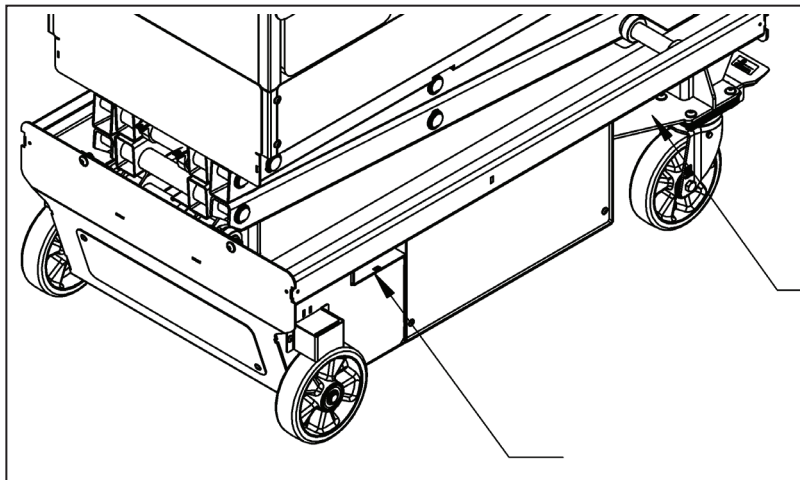


FIGURE 7: Fork Lift Pockets

3.5 | LIFTING AND TIE-DOWN POINTS

Tie-down points are provided in the front and rear of the machine for securing the machine on a trailer or truck bed for transport between places of use. They may also be used as lift points.

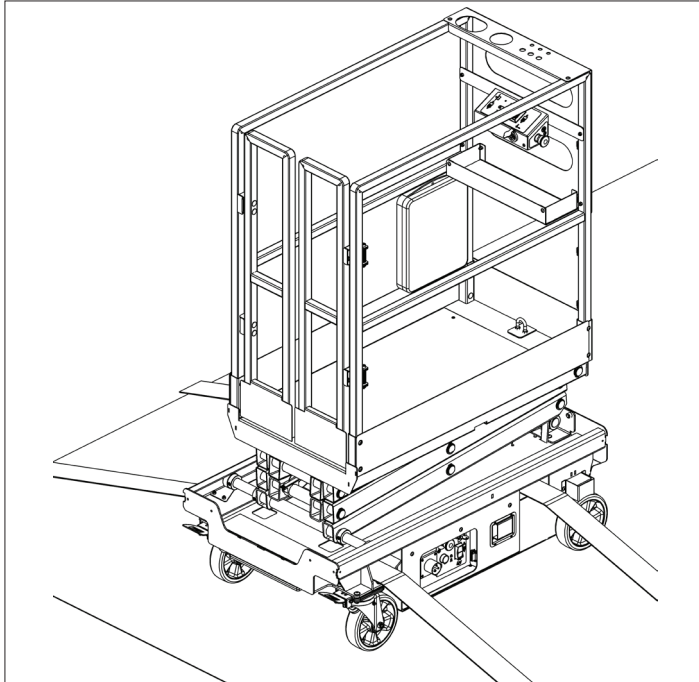


FIGURE 8: Tie-Down

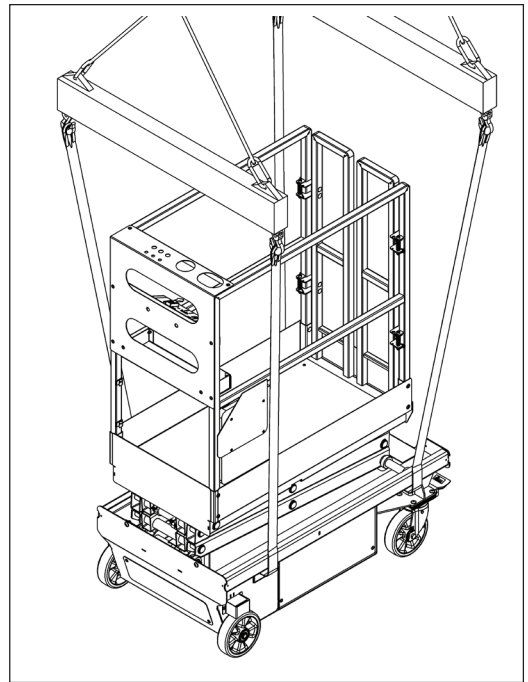


FIGURE 9: Example Sling/Lifting

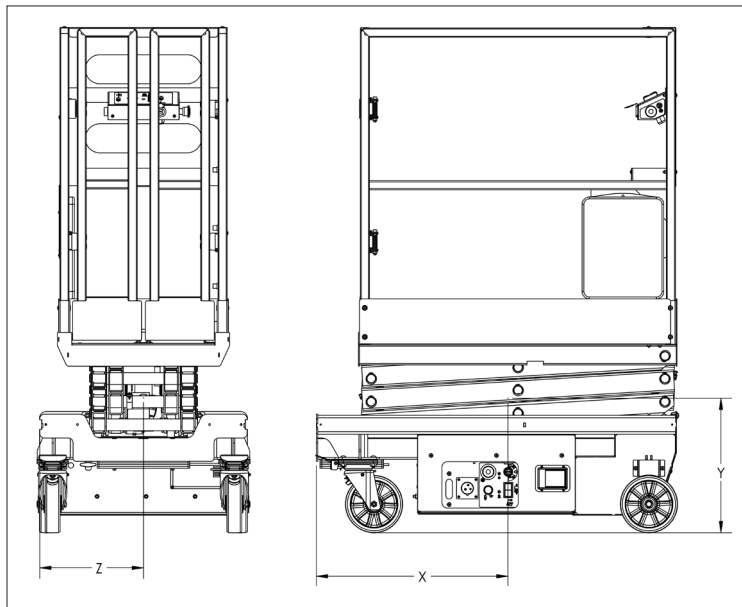


FIGURE 10: Centre of Gravity

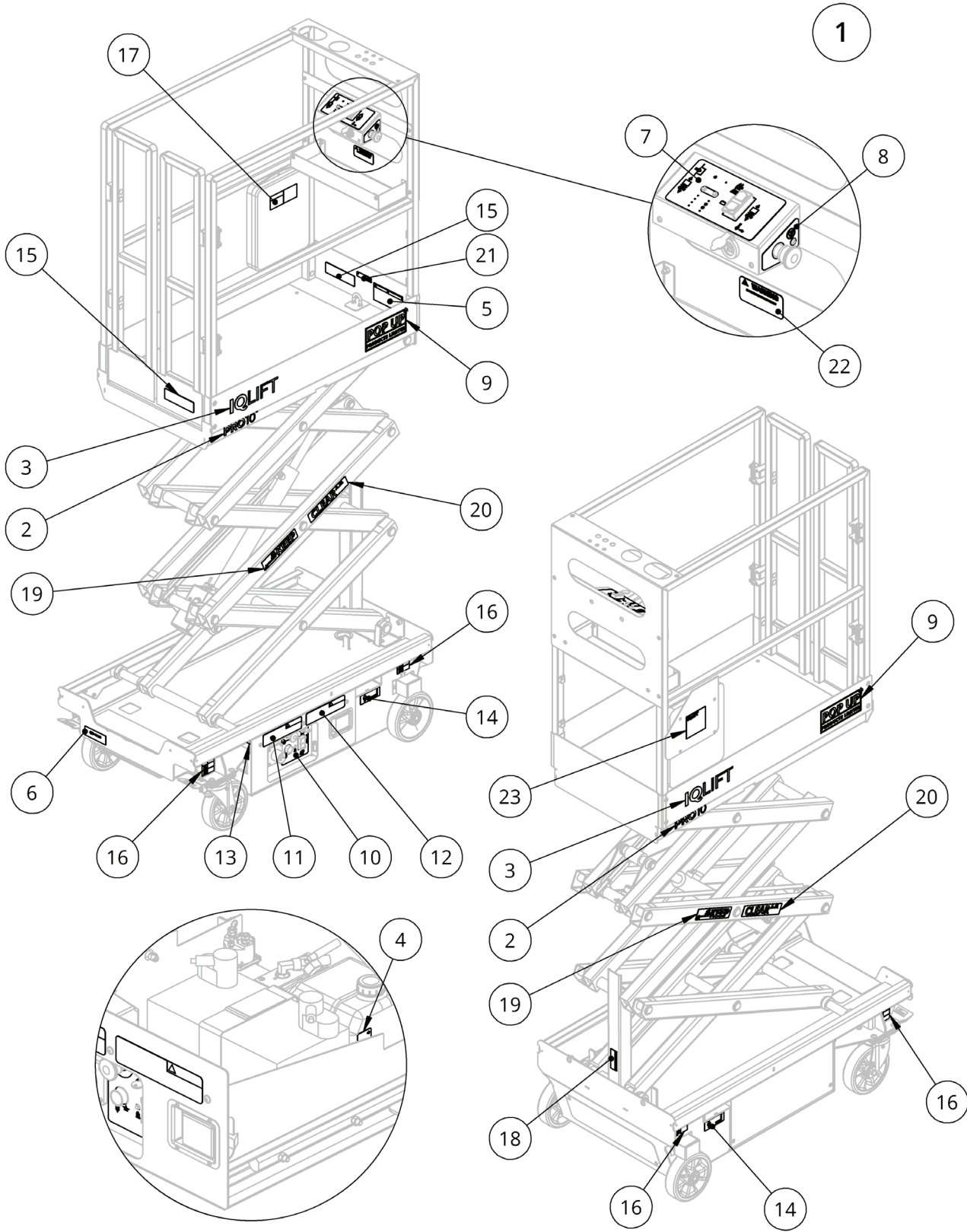

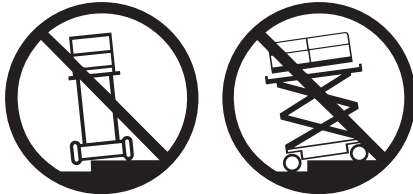


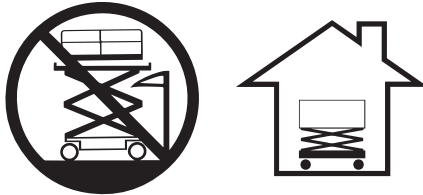
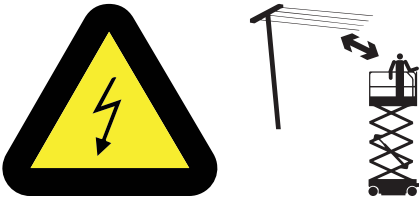




FIGURE 11: Decal Locations


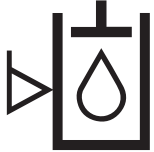
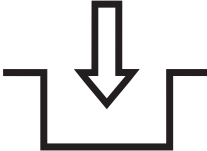

5.1 | BEFORE YOU OPERATE

Before use each day or at the beginning of each shift, the machine shall be given a visual inspection and functional test. Repairs (if any) must be made prior to operating the machine, as it is critical to ensure safe operation of the machine. A checklist for pre-start inspection can be found in the Daily Maintenance section of this handbook.



**THE OPERATOR MUST BE AWARE OF THE ENVIRONMENT.
DO NOT RAISE THE PLATFORM IF THE MACHINE IS NOT ON A FIRM,
LEVEL SURFACE.**

- Check that the work area is safe.
- It is not recommended to maneuver the unit on a slope greater than 5°.
- Machine must be on a hard, level, surface before operation.
- Engage the manual brakes on the rear castors before elevating the platform.

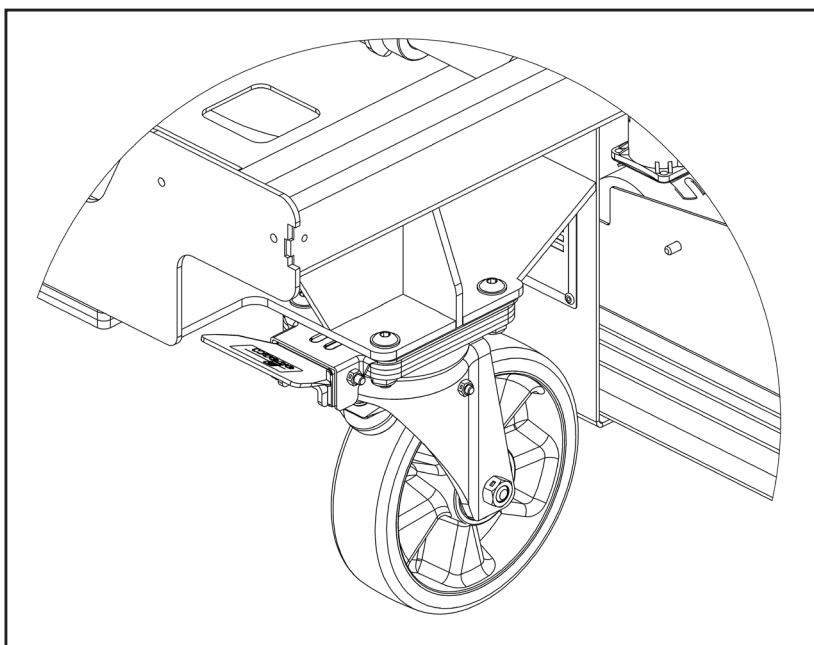


FIGURE 12: Parking Brake

- Ensure that the key in the lower control panel is in the "ON" position for the chassis or platform control.
- Enter the work platform in the stowed position using the constant three point contact method.
- Follow all general rules and precautions stated in this handbook.

5.2 | WHEN WORK IS FINISHED

- When finished with the machine, place the platform in the stowed position.
- Carefully exit the platform using the constant three point contact method.
- NEVER JUMP OFF PLATFORM.
- Park the machine on a level surface.
- Ensure that the manual brakes (on the rear castors) are engaged.
- Remove key from ground control panel to prevent unauthorised use. The key may be padlocked in the handbook box to secure in the isolated position.

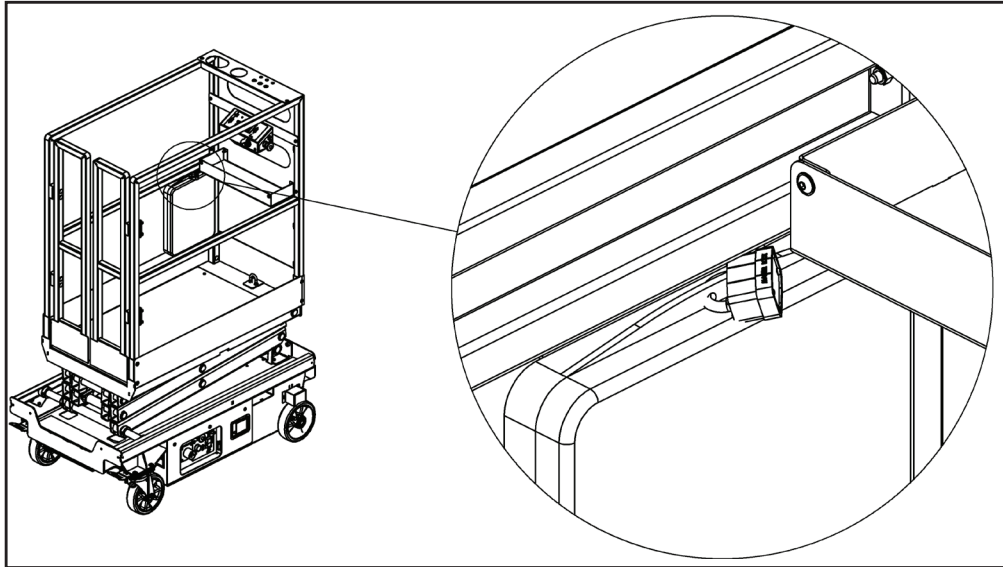


FIGURE 13: Padlock Example

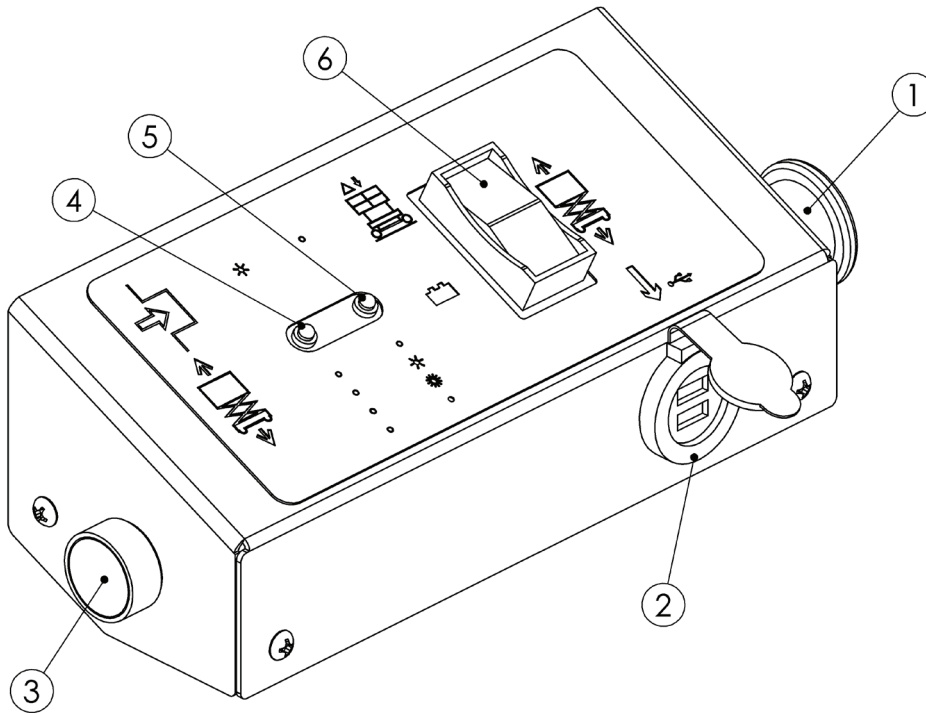


FIGURE 14: Platform Controls

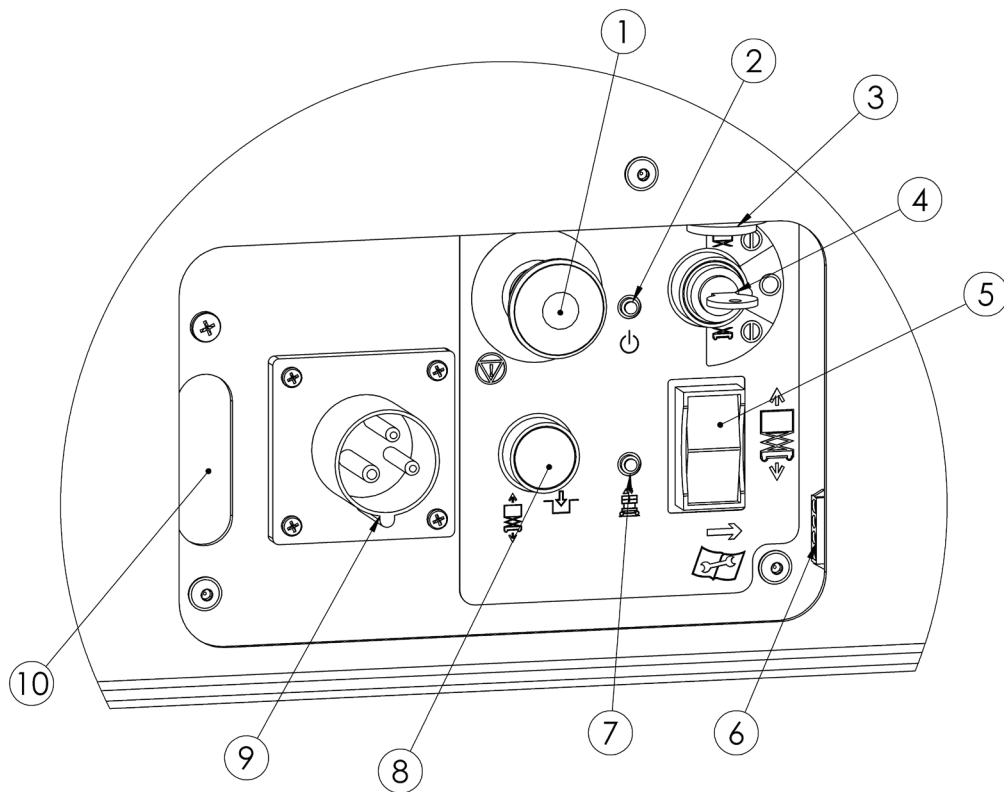


FIGURE 15: Ground Controls

5	Elevate/Lower Switch Push the top part of the rocker to elevate or the lower part to descend.
6	Diagnostic Connection Port Used for connecting EZ Cal diagnostic tool.
7	Overload Indicator Light Illuminates when stowed, beginning to elevate and checking for overload.

SECTION 6 | DAILY MAINTENANCE

6.1 | DAILY MAINTENANCE

Failure to perform inspections and preventative maintenance at recommended intervals may result in the unit being operated with a defect that may result in injury or death of the operator. Regular inspection and conscientious maintenance is important to efficient economical operation of this machine. It will help to assure that equipment will perform satisfactorily with a minimum of service and repair. Make checks at the stated intervals or more frequently if required by local operating conditions. A Pre-Start Inspection Checklist is included in this handbook.

Additional maintenance for use by trained personnel is included in a separate Maintenance & Troubleshooting Handbook. Refer to the Maintenance & Troubleshooting Handbook for Pre-Delivery/Frequent and Monthly Checklists and replacement part information.

6.2 | BATTERY CHARGING

This unit is equipped with a deep cycle 12-volt battery. The care and maintenance of your battery has much to do with how well this unit functions. Battery wiring should be checked monthly.

Note: The surrounding temperature greatly affects the power reserve within a battery.

EXAMPLE: A battery that is 100% charged at 27°C drops to 65% at 0°C. At -18°C, this battery will drop to 40% efficiency.

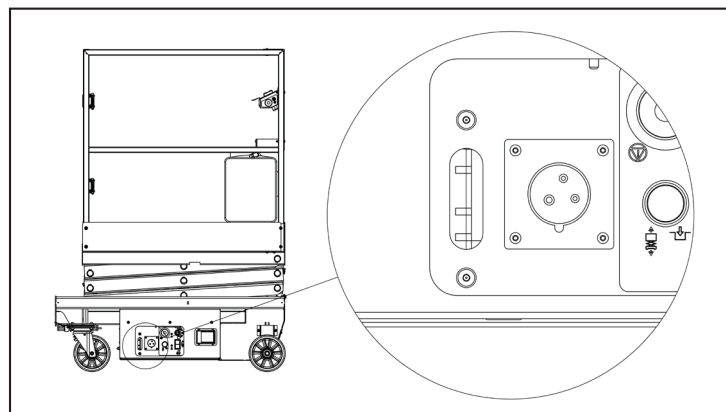


FIGURE 16: Battery Charger Connection and Charger Light Locations
